Brief of the Assignment:

The study focuses on the environment of Greater Khartoum, the Capital of Sudan which is the hardest hit by intensive urbanisation and the consequential physical distortions primarily caused by incessant waves of displaced people and migrants who accumulated in Greater Khartoum and transformed it into unique mixture of nationalities, traditions and customs and made it both multi-cultured and multi-ethnic, The scope of works include studying and evaluating the major components of the urban environment, namely, water, land, air, air, energy and the living creatures. The text report of the evaluation study incorporated a lengthy part on water, wastewater and stormwater drainage systems giving a detailed account of the prevailing conditions of these systems and proposal for their upgrading for the purpose of environmental enhancement.

The KSESAE study has assessed and evaluated the overall impact on the environment and the results of the critical evaluations of all analyses conducted both in the field and at the desk have been displayed wherever appropriate in the Report which includes:







Brief of the Research:

This research was conducted by Dr. Bannaga immediately after he left office when he was Minister of Housing and Engineering Affairs, State of Khartoum and the research foundings are presented in a book entitled:

Peace and Displaced in Sudan

Foremost of the problems facing Khartoum and exemplified in the book at the time was the crisis of the displaced who caused a nightmare to the communities and their successive governments? Their predicament created a demographic and economic defect, which called for an urgent intervention and action, despite the difficulty of rehabilitating and integrating them into the community and the need to provide services, especially water and sanitation at a time when Sudan faced a serious economic depression and harsh social conditions that prevailed for a lengthy period.

The nature of Dr. Bannaga's assignment, his proximity to the problem and his search for containing the difficulties encountered by the IDPs in Khartoum State infused him with a yearning desire to explicate this problem in order to identify probable solutions. The research has been published in a book by the Zurich University, Switzerland, under the title: "Peace and the Displaced in Sudan".

The book has been divided into eight chapters, each elaborates on one of subjects in detail.

It is to be noted that the book was promoted by the Sudanese Council of Ministers.






The Homeless Masses at Home: Identifying and Tackling the Problems and Issues of Internal Displacement in the IGAD African Region

Brief of the Research:

This research is made for IGAD region and endorsed by the IGAD Council of Foreign Affairs Ministers (Sudan, Kenya, Eritrea, Djibouti, Somalia, Ethiopia and Uganda). It has also been published in a book by Zurich University, Switzerland, under the title: "The Homeless Masses at Home: Identifying and Tackling the Problems and Issues of Internal Displacement in the IGAD Region".

This book gives detailed information about the IDPs in the IGAD region. It documents experiences in quantifying and tackling their problems and overcoming the effects of internal displacement with a special reference to the Sudan experience where the majority of IDPs are amassed. One of the objectives of the study is to produce a document that discusses all aspects of internal displacement reflecting the huge scale of displacement and in particular the problems and the challenges facing the IGAD region. IGAD region is next to none with respect to the masses of the displaced population in continuous flight, their effect on the community and the physical environment and the effect of the community upon them.

Brief of the Research:

The research confirms that a dwelling is not only confined to the sheer site to house a family but has also become an instrument contributing to tapping revenue resources for an individual or a family as it may provide an appropriate environment for production and economic activity along the lines of productive families and consequently, home constitutes an extra resource to create additional revenue tapping resources to both the individual and the productive family. It also represents a secondary resource contributing to the national products even though at a small scale... Housing is not only important from an economic and social point of view but it exceeds this concept to contribute in creating employment opportunities as it provides transitional and permanent employment for the building market and also contributes to the gross national product as it provides a principal market for the building materials. Preliminary studies indicate that more than 25% of our national wealth is composed of houses and real estates in the different towns and villages of the Sudan and that more than a quarter of a family's income is spent on housing as a minimum requirement in natural and normal economic conditions. Accordingly, concern over the housing problem and solving its bottlenecks becomes urgent and essential issues for tackling in the Poverty Eradication Project.





Internal Displacement Impacts on Sudanese Towns with Special Reference to Greater Khartoum

Brief of the Research:

This research has come on the verge of an epoch that the Sudan is promised with peace, which hopefully implies an end to the internal displacement episode. Planning and development of theses IDPs settlements is then become a central issue and of concern for the governmental authorities in affected towns. The report highlights the urgent needs of the IDPs to integrate gradually with the settled communities considered in a sectoral manner. Generally, eight sub-sectors have been identified. These are: environmental protection, linkages, drinking water supply and sanitation, shelter and protection against floods, education, health, community development and electricity supply. The natural environment has been harmed by the practices of the displaced who used land for settlement indiscriminately and go searching for fire wood for cooking and forage for their few animals besides cutting the scattered trees for building their shacks, using the grass for roofing, thus they disturb the characteristics of the soil layers. The soil is consequently subjected to weathering beyond remedy. Hence, enhancing the urban structure via spatial organisation and providing renewable energy is vital.

Without paved road linkages, it can be said that these shanty dwellings are difficult to access because they are not connected with made or half made transportation lines. Public transport system is one of the worse public utilities. It is sufficient to say that some people the IDPs commuted in long vehicles best used for livestock and meat marketing. As an urgent plan for relieving the situation, construction of 83 km of roads is deemed necessary.

The water supply system in the irregular settlements depends on groundwater abstraction through boreholes and hand pumps. Distribution of water is almost via water vendors with prices higher than the KSWC charges, which provide regular supply via its ailing network. As an urgent plan, it is thought that more wells should be drilled and piping network should be introduced.
